This is a request for upgrades to the Florida Gateway College Public Service Training Center located in Olustee, Baker County Florida. This multiphase project would involve upgrades to the current facility which was originally home of a naval stores experiment facility in the late 1930's and 40's, construction of fire towers for firefighter training and construction of an emergency vehicle operations range as well as a three-quarters of a mile road course for law enforcement, emergency responder, and firefighter driving certification. FGC has the support of the Sheriffs of Baker, Columbia, and Union Counties as well as fire departments in Baker and Union and the cities of MacClenny and Lake City. Each entity has provided letter of support for this project.
