Florida Family produces hundreds of videos annually of the hardest to place children in Florida's foster care system who are awaiting adoption. The success rate of placement for those foster youth that are featured is over 50%

Forever Family advertisements are currently seen from the keys all the way through central Florida on NBC, CBS and ABC stations.

The expansion of Forever Family's Child Safety and Adoption Initiative will have the added benefit of producing a net savings for the state of Florida.

By recruiting high-quality foster parents, mentors and Guardians, and supporting Independent Living programs and job recruitment, Forever Family increases the likelihood that youth who age out of the foster care system, will be better prepared to contribute productively to society. Thus, saving future dollars for criminal justice and other social welfare programs.
