The Grove Land Reservoir and Stormwater Treatment Area (GLRSTA) will provide treatment and retention of surface waters located in the C-23, C-24, and C-25 canals helping reduce nutrient loads discharged to the sensitive estuarine ecosystems within the Indian River Lagoon (IRL) which are vital to the local environment and economy. Not only does the project benefit the IRL, but also users in the Upper St. Johns River basin since water could be discharged into the St. Johns River during the dry season months. The requested funds will be used to complete the project development and environmental analysis (PD&E) which was first funded in the fiscal year 2015-2016. Tasks associated with funding in the fiscal year 2016-2017 would include continued planning and coordination with agencies, stakeholders, and Water Management Districts, completion of the 30% design drawings and specifications, responding to requests for additional information associated with permit applications, and continued project management and administrative services. The requested funds will be spent through contract agreements between Evans Properties, Inc. and consultants with expertise in the fields associated with the project tasks.
