The funding will be used to finalize the rehabilitation of this 1898 historic structure. Current grant funds of \$325,000 and matching funds of \$175,000 are being used to repaint all exterior bricks, as well as replacement of windows and repairs to the roof. New funding will be used to bring the structure up to current building codes. Examples of work to be completed are the replacement of all mechanical, electrical and plumbing systems, ADA access, FEMA floor elevation compliance and fire suppression system for the building. Additional work needed are a site interpretation analysis and exterior site restoration analysis. The target population to be served will be the City of St. Augustine and St. Johns County in excess of 200,000 in population.
