The state funding would be used to acquire approximately 43.4 acres of wetlands and flood plain contiguous to and including portions of Howell Creek within the City of Winter Park. This watershed is important statewide as it drains to Lake Jesup within the middle St. Johns River Basin and is part of the Basin Management Action Plan for the improvement of water quality with Lake Jesup.

These wetlands are also a wildlife corridor and are heavily used by migratory birds during the spring and fall migrations. These wetlands are presently impacted by several exotic invasive vine species which hinder their effectiveness. Coverage of these vines is estimated to be 60 to 80% over the wetland parcels. The City currently owns and maintains over 50 acres of wetlands adjacent to the parcels proposed to be acquired. The exotic vine infestation on these parcels for acquisition impact our ability to properly maintain the City owned parcels. The desire is to acquire and enhance these privately owned parcels to reduce the exotic vegetation and improve the native species and wildlife habitat along this corridor. Additionally the City desires to improve water access for canoes and kayaks through improved maintenance of these parcels.

The City would provide in-kind matching funds through personnel and material expenses to perform the initial and continued maintenance of the wetland parcels estimated to be \$100,000 the first year and \$30,000 for each year following.
