This legislative funding request involves the renovation of boat ramps that have fallen into disrepair over the years and would add new boat ramps to increase efficiency and decrease damage to canal banks in areas where no ramps exist. This project would enhance departmental efficiencies by allowing staff to deploy boats closer to the work site thereby reducing boat travel time. In addition, it would enhance the effectiveness of the City's cleaning operations, thereby reducing pollutant and invasive weed loading of the South Florida Water Management District C-13 Canal which supplies many important wellfields in the area.
