The requested funds will be directed at reducing the backlog of critical deferred maintenance issues on the Lee Campus. FSW was recommended to receive \$2,358,200 in the original House budget adopted in 2015 and in the CIP-2 by the FLDOE in August of 2014 for the 2015-16 budget. This amount did not appear in the final conference report in the summer of 2015. We are seeking the recommended funding for both 2015 (not received) and the original recommended sum of \$2,119,601 for 2016-17 to stay on schedule for deferred maintenance, with the total of \$4,477,801.
