The Liberty County Sheriff's Office is a building construction project that includes the new construction of a proposed single story building on an existing site that is approximately 6,000 square feet. All funding will be spent on the construction of the building which includes electrical, mechanical, plumbing, masonry, and roofing work associated with the project. The current Sheriff's Office consists of two old modular type homes which are in a dilapidated state, additionally the investigations section is housed in a 15X20 shed (attached pictures). None of these structures provide any safety or security to the employees and general public who visit the Sheriff's office. The new building will also allow for proper security of criminal evidence which is housed in one of the modular homes and will allow our 911 dispatch center to be located within the Sheriff's office and not a different location. Liberty County is a fiscally constrained County with a millage rate of 10 mills; the Ad Valorem tax generated is a little over \$2,000,000 with much of the County restricted from growth due to the large ownership of governmental lands. The monies used to fund this project will greatly enhance the services to the citizens of Liberty Counties as well provide a safe and secure consolidated location for all services utilized for Law Enforcement purposes.
