Additionally, the project will allow the Zoo to educate Florida residents and visitors about manatees and water conservation. Construction progress on repairs and renovations to the Manatee Hospital life support and containment systems will be used to document performance on the specific project. The Zoo fully documents its care of each manatee treated at the Hospital. At the conclusion of the project, the Zoo will be able to measure the effectiveness of its water conservation efforts.
