Pinellas County is one of the premiere tourist destinations in the state of Florida. Pinellas County alone accounted for over 6 MILLION annual visitors to Florida with an economic impact of over \$8.5 BILLION dollars to states economy. One of the main attractions for visitors to Pinellas County are the beautiful Gulf Beaches. The City of Madeira Beach is a popular destination for beachgoers and even though small in size, accounts for over 2900 of those tourist dependent jobs in the county.

The city has never received beach renourishment funding in the past due to the long time use of a ?beach groyne? system that captures sand as it flows down the coast and in storms. This system has saved the State of Florida millions of dollars in beach renourishment funding over the decades it has been in use.

However, the system is aged and is in dire need of cosmetic refurbishment.

Not only is it currently lacking the structure to facilitate its purpose of capturing sand, the system has eroded to a point where it could pose a public danger with sharp edges and missing chunks.

The city is requesting that the state provide \$500,000 towards the projects total cost of \$1,000,000. The city will provide the remainder of the funds for the project. Also, it should be noted that this project has been permitted by the Department of Environmental Protection and is ?shovel ready? as soon as funds are received.
