The purpose of the budget request is for the construction of three multi-purpose buildings on the site of the Hillsborough County Fairgrounds.

One 70 x 150 building and another 80 x 150 building will be located adjacent to the existing Multi-Purpose Exhibition facility. The existing 20,000 square foot building consists of 7,000 square feet of climate controlled and 13,000 square feet of naturally ventilated exhibition space used during the annual fair. This space is available the balance of the year for trade shows, public meetings, luncheons and other events.

The two proposed buildings will be used for livestock exhibition during the fair, and it will be available for public use the balance of the year.

The third proposed structure is smaller and will be used for the Community Stage during the annual fair, and it will be used as a multi purpose storage building the balance of the year. This building will be 60 x 70.

The County Fairgrounds facilities are located on a four lane evacuation route and offer an ideal location as a post storm remediation facility for the entire eastern Hillsborough County area.
