The Music Education Pilot Program will establish a task force to examine the effects music has on early childhood education.

The funding for this program will be primarily directed towards the chosen school districts to operate music education programs in grades K-2. In addition, a portion of the funding will be directed to the University of Florida to conduct an effectiveness study on the pilot program. Researchers from the University of Florida's College of Education will collect and analyze quantitative and qualitative data for the next three consecutive years regarding this program and present its findings to the state.

This program will be a considerable benefit to the state by establishing tangible data sets which will provide the state of Florida with research in analyzing the effectiveness music education has on student achievement.

In collaboration with the University of Florida, the Music Education Pilot Program will provide the opportunity for students in the chosen districts to participate in music education while making a significant contribution to the existing research on the subject.
