The proposed trail is a 1.22 mile hard surface sidewalk trail located within City of Ocoee an FDOT right-of-way. The trail sidewalk construction includes linear swales and closed drainage to drain the project, miscellaneous signage, and amenities are possible. No wetland mitigation is required. The trail/sidewalk project will provide a direct connection to the historical downtowns of the City of Ocoee and the City of Winter Garden. The prospective downtowns are distinctively different with respect to physical characteristics and function. The proposed trail provides an opportunity for residents of each city to enjoy the varying functions of each downtown. Economic benefit; growth of downtown, SR 429 corridor; Growth of ancillary business along the Franklin Street Corridor. Recreation: Provide access to Starke Lake a Florida Game and Fish Commission "Fab Five" Lake; provide access to City of Winter Garden "Splash Park" ; 1.22 miles of continuous trail for walking, bicycling, etc. Job Growth; a pedestrian trail providing the need for ancillary commercial space catering to active lifestyle; provides a key feature in the criteria for all economic development site locations. Energy Efficiency; Removes need for automobile; Provides safer bicycle access; Reduces emissions from cars. (Paving 696,2200K, Engineering/Survey 125,642K, Contingency 16,752K).
