Nearly half of the high schools in Florida today are offering alternative solutions to the state run FASTER system due to the limitations and delays caused by utilizing FASTER. FASTER is a free service so that means that parents/students who opt to use alternative means for electronic transcript delivery, must pay out of pocket if they have the means to do so.
