Florida PBS LearningMedia is an open platform online digital resource repository that utilizes 40 years of PBS broadcast material along with content from over 150 partners including the Library of Congress, Smithsonian, The National Science Foundation and NASA, to repurpose existing and new content into small, standard-aligned segments to increase outcomes and engagement. Whether it is a video clip, a self-paced lesson or an image from the Smithsonian, students, teachers, parents, and stakeholders can choose from over 100,000 resources that give them the opportunity to view something directly related to Florida's educational standards.

Funds will be spent to maintain operations and licensure of the custom system which maintains the alignment of current resources to Florida's Voluntary Prekindergarten, Next Generation Sunshine State and Florida Standards; ensure new content is aligned to Florida's educational standards; support a Florida helpdesk; allow for targeted training and educational outreach; and approximately 5% will be spent on administration.

Since the Florida PBS LearningMedia is an open platform it is available to Florida teachers, students, parents, mentors, and education stakeholders.
