The Pinellas Education Foundation respectfully asks the legislature to support a request of \$1,000,000 in funding for the Florida expansion of Future Plans which will permit 250,000 Florida high school and college students to access the critical career planning tool, beginning in September 2016. This request represents a sub part of the entire project. The requested funds will be spent as follows: Server hosting fees, content updates, customized reports, help desk, and training costs - \$430,000; Contract consultants - program management and career coach training -\$200,000; Project Supervisor - PEF Staff - \$50,000; Audit Fees - \$10,000; Accounting Fees -\$50,000; Marketing Fees -\$15,000; Legal Fees -\$10,000; Webinar development -\$40,000; Program Evaluation -\$90,000; Future Plans External Relations Program Manager @1FTE (includes salary and benefits) -\$80,000; Laptop, Cell Phone, Equipment and travel costs for Future Plans External Relations Program Manager -\$25,000. Total: \$1,000,000

High School and College Students across the state of Florida will benefit from the receipt of State Funds. Additionally, funds will impact the teachers, family members, businesses, community colleges, post-secondary educational institutions, and entire communities by expanding the tax base with a larger pool of workers re-investing in our cities and towns.
