PPEC Reimbursement

Requesting a 10% increase to \$211.19 per day, an increase of \$19.20/day. Since 2006, the rate has only been increased once, by \$15.94.

PPEC's are currently reimbursed at \$191.99 per day for up to twelve hours of skilled nursing.

Rising wages and cost of employee benefits have been hard to absorb.

Current PPEC reimbursement is the lowest in the country and will remain so even after a 10% increase.

Overall impact to Medicaid budget would be less than \$6 Million, of which less than half would be state dollars with the remainder being federal share.
