This appropriations is to open and maintain critical passes in the Tierra Verde community. Specifically, sand is flowing south from upland beaches and has completely closed the northern Shell Key pass and is rapidly filling in the opening to our Grand Canal. The environmental and economic harm will be devastating.

Environmental harm to the unique and pristine Shell Key Preserve is already occurring. Valuable sea grasses and fish spawning grounds are degrading from declining water quality. Shell Key has become a peninsula on the land bridge created has allowed predators access to the bird nesting areas as well as to turtle eggs. The Grand Canal provides the only water access to hundreds of our citizens as well as to a large marina and new hotel under construction. Lost jobs, declining real estate values, diminished recreational opportunities and environmental harm will be the result of inaction.
