There is generally a shortage of commercial truck drivers across Florida and the rest of the country. This occupation is one of the top 10 in demand across North Florida and presents an opportunity for TCC to partner with the business community to build a qualified workforce and create jobs. Presently the closest public, post-secondary, commercial truck driving program is nearly two hours away.

Florida colleges serve both a local and state wide interest by providing a post-secondary academic and workforce resource for Florida's citizens. Funds will be used to purchase trucks, driving simulator, fuel, insurance, retrofit classroom and other program related items. It is planned that the Commercial Vehicles Drivers Program will train 150 students per year. (anticipated starting salary for commercial truck drivers is \$33,000 annually); the State of Florida benefits by increasing its workforce, and businesses across the state in need of commercial truck drivers benefit by increasing available workforce.
