The newly built Family Center located in a very low income area will provide transportation, tutoring, social integration, core life skills and health and wellness training for the disabled and high risk youth populations in Miami and surrounding areas. The expected program results and benefits associated from the requested funds are increased GPA and graduation rates, improved social and life skills, college scholarship opportunities, reduction in juvenile crime, job training, improved behavioral health and wellness. The students will benefit directly, but the community will benefit most the inclusion of Developmentally Disabled students with very few after school activity options and by a reduction in juvenile crime. The First Tee Program will provide physical education and exercise options for a very underserved population. Also high risk youth from low income neighborhoods will learn proper social skills and the 9 core values of the game of golf: Honesty, Respect, Integrity, Courtesy, Confidence, Sportsmanship, Responsibility, Perseverance, and Judgement. As incentive to bring up their grades and participation and attention skills, they will also have an opportunity to access the course, will be provided with proper attire and equipment and will experience professional instruction, along with instruction in health and wellness program.
