The goal of our mental health rehabilitation program is to find a job for every one of our members who wants one, help them build friendships, provide housing support and promote education accomplishments, such as college degrees, GEDS, or vocational education. The Clubhouse provides the basis for healthy recovery from mental illness and helps our members live fulfilling and productive lives. The Key Clubhouse is part of an international model that believes that meaningful work is a critical component in overcoming the effects of serious mental illness and returning individuals to being productive members of their society. Headquartered in New York, there are 350 Clubhouses around the world. Key Clubhouse is the only self-standing Clubhouse in Miami Dade County. In the last year 96% of our active membership have stayed out of crisis units.
