Vincent House proposes the expansion of our Recovery through Work Program with the creation of a new facility, Vincent House-Hernando. By using work and employment as the healing factors, Vincent House restores hope and transforms lives of those most affected by severe and persistent mental illnesses. Vincent House-Hernando will apply vocational training and gainful employment as the means of helping adults living with illnesses such as schizophrenia, bipolar disorder and post-traumatic stress disorder lead productive and meaningful lives. During the first year of operation, Vincent House-Hernando will provide daily vocational training and job placement services to 75 individuals. Services will gradually expand to 150 individuals/year by the third year of operation.

State recurring funding of \$600,000 will be spent as follows: Salaries & benefits - \$500,000, Professional Services - \$45,000, Insurance - \$45,000, Training - \$10,000. State non-recurring funding of \$250,000 will be spent on purchase of the building and renovations. Vincent House-Hernando fundraising and program revenue funding of \$170,000 will be spent on supplies, marketing, utilities, telephone, transportation, computers & office equipment, furniture, kitchen equipment, and grocery purchases.
