The City of West Park intends to develop a park facility within its recently acquired parcel of 14,000 square feet (SF), which is known as Water Tower Park. This park development project is the City's continued attempt to meet the minimum requirement of three (3) acres of community Level Park for every 1000 residents. As currently envisioned, the proposed park development would be organized around roughly 9,000 square feet shade structure covering a collection of youth oriented playground equipment benches and picnic tables. An irrigated and lighted landscape installation interwoven with paved footpath would be flanked by a perimeter split rail wood fence. Funding is being requested to complete the construction of this facility, which will remove slum and blight. In addition, the project will enhance the quality of life of residents and visitors, by fostering a location for recreation and family engagement. This project will impact residents and visitors within south region of the state. Upon project completion, the City will maintain the facility.
