MEMORANDUM

RE: Councils and Committees

Thank you for your time and effort in responding to my request for your preferences on committee assignments. Based on your input and a thorough review of the organizational strengths and weaknesses of the past Session, I will be releasing the 2009-2010 council/committee reassignments this afternoon.

Prior to the release of the specific committee assignments this afternoon, I thought it important to explain the overall structure and approach. My guiding principles have been threefold: to improve efficiency, to maintain stability, and to build continuity with the future. To improve efficiency, I have adjusted council groupings (“time blocks”), achieved better alignment between the House and the Senate by leaving vacant 4 committees and 1 council with identified workflow or structural issues, and attained functional councils and committees by removing the variations in size. To maintain stability, I have retained the core structural framework, given the highest possible accommodation to individual member preferences, and increased the distribution of leadership assignments. To build continuity with the future, I have expanded freshman member involvement at the council level, distributed freshman and sophomore members across a wider array of subject matter, and provided for wide participation on appropriations committees.

The size of House councils and committees will be as follows: the Appropriations Council, the Rules & Calendar Council, and the Policy Council are **18** members each; all other councils are **16** members each; and all committees

are **14** members each. I believe this will give members a greater opportunity to play a meaningful role on the councils and committees on which they serve.

I am leaving some committees vacant to provide a broader perspective and better alignment with Senate structure. The remaining council or committee will do the work of prior councils or committees without the need for change in House rules. These are as follows:

- The same members will be appointed to both the Full Appropriations Council on Education & Economic Development and the Full Appropriations Council on General Government & Health Care, functionally merging them into one council.
- The State & Community Colleges & Workforce Appropriations Committee will be left vacant. I will refer higher education-related bills with a fiscal impact to the State Universities & Private Colleges Appropriations Committee.
- The Healthy Seniors Appropriations Committee and the Human Services Appropriations Committee will be left vacant. I will refer health care and human services bills with a fiscal impact to the Health Care Appropriations Committee.
- The State & Community Colleges & Workforce Policy Committee will be left vacant. I will refer higher education-related bills to the State Universities & Private Colleges Policy Committee.

The committees to which no members are assigned will no longer meet and legislation will not be referred to them.

Attached you will find a general schedule showing the new council and committee time blocks that will be used to build the schedule for each committee week and Regular Session. The revised time blocks will facilitate scheduling, concentrate the primary workload in mid-week, provide enhanced fluidity in moving bills through the process, and allow members to be involved in both health care and education policy, as these two areas consume the major portion of our state's budget.

I am proud of your hard work during the past year, and I expect these improvements to enable all of us to do an even better job this year. I look forward to seeing each of you when you return in October. This coming session will be as challenging as the last, but I am confident that, with these changes and your dedication and hard work, we will be better prepared to address the challenges facing our great state.

Why “Groups” are Important

The House Calendar has traditionally been built using blocks of committees, which are assigned to groups. A Member may only serve on one committee or council within a specific group. Also, because the council chairs control the distribution of time between a council and its committees, Members may only serve on the council that supervises the committee to which they are assigned otherwise a time conflict will likely occur.

Examples

- You **can** serve on Health Regulation Policy Committee and PreK-12 Policy Committee because these committees are in different blocks.
- You **cannot** serve on PreK-12 Policy Committee and Economic Development Policy Committee because these committees are assigned to the same block.
- You **can** serve on PreK-12 Policy Committee and the Education Policy Council because the committee is within the jurisdiction of the council.
- You **cannot** serve on the Health Regulation Policy Committee and the Criminal & Civil Justice Policy Council because both are within the same block and the committee is not within the council.
- You **cannot** serve on the Criminal & Civil Justice Policy Council and the Health & Family Services Policy Council because these councils meet within the same block.
