**Mobile Home and Recreational Vehicle Parks;** Specifies laws & rules to be enforced by DOH; revises applicability of recreational vehicle park requirements to mobile home parks; revises permit requirements; provides construction review & approval requirements for private parks & camps; revises permit application requirements; revises & provides fees charged to operators of certain parks or camps; authorizes persons to request from department review of plans for proposed park or camp; requires certain construction & renovation plans to be submitted to department for review & approval; requires department to establish certain fees; provides department with additional rulemaking authority; provides for state preemption of regulatory & permitting authority for certain standards for parks & camps; increases penalty for operation of park or camp without operating permit; repeals provisions relating to posting & advertising of certain site rates; provides requirements for establishment of separation & setback distances; deletes

provision requiring guest registers to be made available for inspection by department at any time; revises requirements for handling of unclaimed property; provides penalty for failure to depart from park under certain circumstances; bars operator from certain liability. Effective Date: July 1, 2010

**HB 199 by Weinstein** (Similar SB 320)

**Household Moving Services;** Revises term "storage"; provides for biennial renewal of mover & moving broker registrations; authorizes DOACS to extend registration expiration dates to establish staggered dates; requires calculation of biennial registration fees based on annual rate; deletes provision requiring certain movers & moving brokers to obtain local license or registration & pay state registration fee; authorizes mover to exclude liability for household goods packed by shipper under certain circumstances; authorizes mover to refuse to transport or ship household goods under certain circumstances; prohibits mover or moving broker from conducting business without being registered with DOACS; provides penalties; preempts local ordinances & regulations except in certain counties; restricts levy or collection of local registration fees & taxes of movers & moving brokers; authorizes certain counties to require registration & bonding of movers & moving brokers; specifies that local business taxes are not preempted. Effective Date: July 1, 2010

**HB 201 by Porth, Legg, Schwartz** (Identical SB 428)

**Human Services Personnel;** Designates act as "Protecting Florida's Most Vulnerable Citizens Act"; requires owner or operator of child care facility to report background screening results to DCFS before employing person at child care facility; prohibits hiring of person with disqualifying offense without being granted exemption; requires child welfare services staff to obtain child welfare certification; requires DCFS to designate credentialing entity to administer certification process; requires department to develop minimum trainer qualifications; revises administrative penalties; requires owner or administrator of assisted living facility to report background screening results to agency before employing person at assisted living facility; prohibits DCFS & AHCA from granting certain exemptions from disqualification from employment. Effective Date: July 1, 2010

**HB 203 by Reed** (Identical SB 370)

**Community Corrections Assistance to Counties or County Consortiums;** Adds rehabilitative community reentry programs to list of programs, services, & facilities that may be funded using community corrections funds & deletes military-style boot camps from such list. Effective Date: July 1, 2010

**HB 205 by Kriseman** (Similar SB 430)

**Tanning Facilities;** Requires tanning operator or proprietor of tanning facility to witness parent or legal guardian of minor signing written statement before minor is allowed to use tanning device; provides requirements for written statement; revises age at which minor is allowed to use tanning device; prohibits minor younger than certain age from using tanning device at tanning facility; deletes provisions authorizing use of tanning device by

certain minors if accompanied by parent or legal guardian. Effective Date: July 1, 2010

**HB 207 by Kriseman** (Identical SB 358)

**Contamination Notification;** Revises contamination notification provisions; requires individuals responsible for site rehabilitation to provide notice of site rehabilitation to specified entities; revises provisions relating to content of such notice; requires DEP to provide notice to specified entities & certain property owners; authorizes DEP to pursue enforcement measures for noncompliance; revises DEP notification requirements for certain public & private K-12 schools & child care facilities; requires local governments to provide specified notice; requires DEP to recover notification costs from responsible parties. Effective Date: July 1, 2010

**HB 209 by Bullard** (Identical SB 420)

**Student Assessment in the Public Schools;** Terminates administration of FCAT to students in grades 9 through 12; requires PSAT/NMSQT to replace grade 10 FCAT for purposes of measuring student's knowledge & skills; requires students to take PSAT/NMSQT in grade 10 & earn passing scores to qualify for standard high school diploma; requires State Board of Education to designate passing scores; requires use of student performance on PSAT/NMSQT for school grading purposes; provides for application beginning with students entering grade 9 in 2011-2012 school year. Effective Date: July 1, 2010

**HB 211 by Adams**

**Juvenile Justice;** Authorizes conditions of preadjudicatory release for certain children; permits child to be taken into custody for violations of preadjudicatory release conditions; provides that child taken into custody for violation of preadjudicatory release conditions must appear before judge within 24 hours; provides that detention care under specified provision does not require risk assessment; provides for certain kinds of care prior to hearing in certain circumstances; requires compliance with preadjudicatory release conditions; revises provisions relating to detention care; permits parent or guardian of child to be held in contempt if he or she fails to bring or otherwise prevents child from appearing; revises provisions relating to recommendations by probation officers concerning placement & treatment; specifies that court has power to determine appropriate dispositions; requires that reasons for disposition be stated; permits child to be detained in facility other than consequence unit for certain violations if one is unavailable; permits each county to create juvenile crime prevention fund & provides for additional court cost; provides that no juvenile shall be assessed additional court cost if juvenile & juvenile's parents or other legal guardian are indigent. Effective Date: July 1, 2010

**HB 213 by Kriseman** (Identical SB 356)

**Congressional Vacancies;** Provides for special election to fill vacant U.S. Senate position; provides circumstance under which Governor is not required to call such special election; repeals Governor's authority to make temporary appointment to U.S. Senate vacancy. Effective Date: July 1, 2010

**HM 215 by Kriseman**

**United States Senate Vacancies;** Urges Congress to adopt constitutional amendment requiring elections to fill vacancies in U.S. Senate & end appointments to fill those vacancies.

**HB 217 by Glorioso, Porth** (Compare HB 179, SB 316)

**Child-Restraint Requirements;** Provides child-restraint requirements for children 4-7 years old; provides exceptions; redefines term "motor vehicle" to exclude certain vehicles from such requirements; provides grace period. Effective Date: July 1, 2010

**HB 219 by Adams**

**Enforcement of Immigration Laws;** Designates act "Florida Security and Immigration Compliance Act"; prohibits agencies from entering into contract for services with contractors not registered & participating in federal work authorization program by specified date; provides for enforcement; provides schedule for phased compliance; requires Chief of Domestic Security to negotiate terms of memorandum of understanding between state & certain Federal Government entities concerning specified matters related to immigration; provides for establishment of law enforcement training standards & creation of training programs contingent upon federal funding; provides requirements & procedures with respect to determination of lawful immigration status of persons charged with crime & confined to county or municipal detention facility; requires agencies to verify lawful presence in U.S. of applicants for specified state, local, & federal public benefits; requires BOG to set forth policies regarding postsecondary education benefits; provides penalty for knowingly & willfully making false, fictitious, or fraudulent statement or representation in affidavit attesting to citizenship or permanent legal residency. Effective Date: July 1, 2010

**HB 221 by Williams, A.**

**Driving Safety;** Creates "Ronshay Dugans Act"; designates Drowsy Driving Prevention Week; encourages DHSMV & DOT to educate law enforcement community & public about relationship between fatigue & driving performance; restricts use of mobile telecommunications devices by school bus drivers; provides exceptions & penalties. Effective Date: upon becoming a law

**HB 223 by Williams, A.**

**Protection of Children;** Revises definition of "child care personnel" to include persons who work in summer 24-hour camps; requires summer day camps & summer 24-hour camps

to be licensed by DCFS & requires employees thereof to undergo level 2 background screening; repeals exemption from fingerprinting requirements for summer camp personnel. Effective Date: July 1, 2010

**HB 225 by Legg**

**Dispensing of Controlled Substances;** Prohibits registered dispensing practitioners from dispensing more than specified amount of certain controlled substances; provides exception. Effective Date: July 1, 2010

**HM 227 by Adams** (Similar SM 480)

**Control of Florida National Guard by Governor;** Urges Congress to preserve authority of Governor to retain command & control of Florida National Guard & to reject any changes to federal law that would restrict or diminish authority of Governor to activate Florida National Guard in response to domestic crisis, disaster, or other emergency.

**HB 229 by Jenne** (Identical SB 400)

**Rape Crisis Programs;** Requires that additional court cost or surcharge be assessed for violations of specified criminal offenses for deposit into Rape Crisis Program Trust Fund. Effective Date: July 1, 2010

**HB 231 by Kiar** (Identical SB 224)

**Statewide Assessments;** Revises provisions relating to schedule for administering comprehensive statewide assessments to provide exception with respect to certain religious holidays. Effective Date: July 1, 2010

**HB 233 by Kiar** (Identical SB 100)

**Vessel Safety;** Revises certain requirements for operating personal watercraft & requirements relating to boating safety course required for leasing or renting personal watercraft from livery. Effective Date: July 1, 2010

**HB 235 by Williams, A.**

**Lifeline Telecommunications Service;** Authorizes any commercial mobile radio service provider designated as eligible telecommunications carrier to offer Lifeline services; authorizes DCFS, DOE, PSC, & Office of Public Counsel to exchange certain information with eligible telecommunications carriers so carriers can identify & enroll eligible person in Lifeline & Link-Up programs; maintains confidentiality of information. Effective Date: July 1, 2010

**HB 237 by Anderson** (Identical SB 588)

**Efficiency in Procurement and Contracting;** Establishes Advisory Committee on State Procurement for purpose of evaluating state procurement process & carrying out legislative policy; provides policy of Legislature with respect to procurement of goods, services, & facilities by state; provides for membership, organization, staffing, duties, & powers of

committee; requires state agency cooperation; requires reports of committee; provides for termination of committee; provides appropriation. Effective Date: upon becoming a law

**HB 239 by Taylor, D.**

**Volusia County;** Directs board of county commissioners to issue certificate of public convenience & necessity to applicant for licensure as basic life support or advanced life support service that will operate in municipality within county which has population greater than 30,000, upon request of municipality, under specified conditions. Effective Date: upon becoming a law

**HJR 241 by Fitzgerald, Long (Similar SJR 440)**

**Expanding the Public's Access to the Legislative Process and Public Records and Meetings;** Proposes amendment of s. 24, Art. I & ss. 4, 7, & 19, Art. III of State Constitution to provide that 2/3 vote of membership of each house is required to enact public records or public meeting exemptions, authorize challenges in circuit court to reasonableness or interpretation of legislative rules governing public access to legislative documents & meetings, provide that members of legislative conference committees may discuss pending matters with other committee members only at meetings noticed & open to public, prohibit Legislature from considering certain amendments during special session, last 5 days of regular session, & any extension of special or regular session unless amendments were adopted by committee or authorized by 3/4 vote of members of chamber where offered, change format specifications for appropriations bills, & provide that general appropriations acts must be product of joint conference committee except as otherwise provided therein.

**HB 243 by Robaina**

**Standards of Conduct;** Expands definition of term "public officer"; creates additional prohibitions against doing business with one's agency, accepting unauthorized compensation, having conflicting employment or contractual relationships, lobbying, or consulting; revises construction of code of ethics for public officers & employees; provides criminal penalties for code violations. Effective Date: July 1, 2010

**HB 245 by Bernard (Compare SB 436)**

**Community Colleges;** Renames specified community colleges. Effective Date: upon becoming a law

**HB 247 by Weinstein**

**Driving or Boating Under the Influence;** Authorizes law enforcement officer to arrest person without warrant when there is probable cause to believe person has committed any of specified driving or boating under influence violations. Effective Date: October 1, 2010

**HB 249 by Snyder**

**Special Risk Class Retirement Benefits;** Prohibits certain members of Special Risk Class from being reemployed or

contracting with same employing agency from which member retired; extends period of time during which certain Special Risk Class members may participate in FRS DROP; provides legislative findings with respect to state's interest in protecting public's safety & welfare by extending retirement benefits for officers & funding increased retirement benefits in actuarially sound manner; provides declaration of important state interest. Effective Date: upon becoming a law

**HB 251 by Kreegel**

**Clinical Perfusionists;** Specifies financial responsibility requirements for clinical perfusionists; requires supervising physician to be qualified in medical area in which clinical perfusionist performs; prescribes duties of clinical perfusionist; requires clinical perfusionist to convey that he or she is clinical perfusionist to patient; authorizes clinical perfusionist to perform medical tasks & services within certain protocol; prohibits clinical perfusionist from prescribing, ordering, compounding, or dispensing certain drugs or medical devices; provides that clinical perfusionist may administer certain drugs, fluids, & blood products under supervision of physician; exempts perfusionist in training from requirements of clinical perfusionist; requires approval of Board of Medicine & Board of Osteopathic Medicine of training programs for clinical perfusionists; provides certification requirements; provides provisional certification requirements; provides for temporary certificate; authorizes boards to impose penalty against clinical perfusionist found guilty of or investigated for violating certain provisions; authorizes board chairs to appoint certain persons to advise boards; provides duties of boards; provides for denial, suspension, or revocation of certification; requires boards to adopt rules; requires DOH to allocate fees collected to boards; provides exemptions from certification requirements; excludes hospitals from payment of certain costs; provides that act does not prevent reimbursement of employers of clinical perfusionists. Effective Date: October 1, 2010

**HM 253 by Workman, Adams, Ambler, Aubuchon, Crisafulli, Drake, Flores, Ford, Fresen, Hooper, Horner, Jenne, Mayfield, Murzin, Pafford, Precourt**

**Space Shuttle Orbiter Retirement;** Urges Congress to direct that one of retiring space shuttle orbiters be preserved & placed on permanent display at Kennedy Space Center.

**HB 255 by Chestnut (Identical SB 208)**

**Community College Student Fees;** Authorizes community college boards of trustees to establish transportation access fee; limits amount of fee; provides timeframe for fee increase & implementation of increase; prohibits inclusion of fee in calculating amount student receives under Florida Bright Futures Scholarship Program awards. Effective Date: July 1, 2010

**HB 257 by Ford**

**Wreckers;** Revises provisions for exceptions to vehicle weight limits applicable to wreckers; provides that specified license tax provisions apply to wreckers used for certain purposes. Effective Date: July 1, 2010

**HB 259 by Weinstein**

**Capital Felonies;** Provides aggravating circumstance for sentencing purposes if felony committed by person was subject to injunction or protection order against petitioner who obtained injunction or order or any of certain related persons. Effective Date: July 1, 2010

**HB 261 by Evers (Compare SB 200)**

**Parole Interview Dates for Certain Inmates;** Extends from 5 to 7 years period between parole interview dates for inmates convicted of violating specified provisions or serving mandatory minimum sentence under specified provision. Effective Date: July 1, 2010

**HB 263 by Llorente**

**Motor Vehicles;** Requires application form for motor vehicle registration or renewal of registration to include language permitting applicant to make voluntary contribution to Prevent Child Sexual Abuse; requires application form for driver's license or duplicate thereof to include language permitting applicant to make voluntary contribution to Prevent Child Sexual Abuse; requires application form for renewal issuance or renewal extension of driver's license to include language permitting applicant to make voluntary contribution to Prevent Child Sexual Abuse; provides for distribution of funds collected from voluntary contributions authorized under this act to Lauren's Kids, Inc.; provides that such contributions are not considered income of revenue nature. Effective Date: October 1, 2010

**HB 265 by Reagan, Ambler**

**Tax Collections, Sales, and Liens;** Revises, updates, & consolidates provisions of ch. 197, F.S., relating to definitions, tax collectors, lien of taxes, returns & assessments, unpaid or omitted taxes, discounts, interest rates, DOR responsibilities, tax bills, judicial sales, prepayment of taxes, assessment rolls, duties of tax collectors, tax notices, delinquent taxes, lienholders, special assessments, non-ad valorem assessments, tax payments, distribution of taxes, advertisements of property with delinquent taxes, attachment, delinquent personal property taxes, sales of property, tax certificates, tax deeds, & tax sales; authorizes tax collectors to issue certificates of correction to tax rolls & outstanding delinquent taxes for uncollectable personal property accounts; requires tax collector to notify property appraiser; revises, updates, & consolidates provisions of ch. 197, F.S., relating to deferral of tax payments for real property, homestead property, recreational & commercial working waterfront property, & affordable rental property; provides authorization & requirements for purchase of county-held tax certificates; specifies required amounts to be paid; provides for fees; provides for electronic services. Effective Date: July 1, 2010

**HB 267 by Bullard (Identical SB 134)**

**Culpable Negligence;** Creates "Officer Jose Somohano Assault Weapons Act"; provides that person commits felony of third degree if he or she stores or leaves assault weapon within reach or easy access of another person if that person obtains weapon & uses it to inflict injury or death; provides exceptions; defines "assault weapon." Effective Date: July 1, 2010

**HB 269 by O'Toole (Identical SB 236)**

**Vanpools;** Creates exemption from tax on sales, use, & other transactions for leases of passenger vehicles for commuting purposes; defines term "vanpool lease." Effective Date: October 1, 2010

**HB 271 by Kiar (Identical SB 444)**

**Offenses by Public Officials or Others;** Prohibits engaging in certain activities to deprive another of his or her right of honest services; provides for construction in accordance with specified federal law. Effective Date: October 1, 2010

**HB 273 by Hudson**

**Water and Wastewater Utilities;** Provides for recovery through surcharge of costs for water & wastewater system improvement projects; requires PSC approval of surcharge; limits surcharge amount; provides requirements for surcharge billing, reconciliation, & adjustment; provides project eligibility criteria; provides requirements for notice, maintenance, & availability of certain records. Effective Date: July 1, 2010

**HB 275 by Grimsley (Identical SB 516)**

**Insurance Coverage for Prescription Drugs;** Prohibits limiting, reducing, or denying prescription drug coverage under health insurance policies or health maintenance contracts for individuals under specified circumstances; preserves insurer or HMO authority to make specified uniform changes; requires insurers & HMO's to notify insureds of such changes; specifies nonapplication to Medicaid managed care plans. Effective Date: July 1, 2010

**HB 277 by Frishe**

**Alimony;** Allows for award of more than one type of alimony; revises factors to be considered in whether to award alimony or maintenance; provides for award of bridge-the-gap alimony; provides that such award is not modifiable; provides for award of rehabilitative alimony, durational alimony, & permanent alimony in certain circumstances; provides for modification or termination of such awards. Effective Date: July 1, 2010

**HB 279 by Frishe (Similar SB 586)**

**Data Destruction;** Requires all public agencies & private entities that collect personal information to adhere to specified procedures when destroying such information; requires such agencies & entities to maintain copy of such procedures; requires all state agencies to submit sampling of sanitized media to third-party vendor for verification of data destruction; requires DMS to adopt rules. Effective Date: July 1, 2010
